West Bengal Scheduled Castes, Scheduled Tribes & Other Backward Classes Development & Finance Corporation ("WBSCSTOBCDFC" or the "Corporation"), having its office at CF-217/A/1, Sector - I, Salt Lake, Kolkata-700 064, West Bengal intends to procure musical instruments traditionally used by scheduled tribe communities (Munda, Oraon, Santhal etc.) as per specifications as mentioned here-in-after for the purpose of distribution among the tribal cultural groups on 15/11/2022 in connection with celebration of 147 Janmojayanti of great freedom fighter Birsa Munda.

4. E-Tender is invited for supply of 900 sets of musical instruments as per para 3 above within 2 days (48 hrs.) after award of contract.
5. Instructions to Bidders: i) Bidders are to submit documents evidencing capacity of manufacture/supply of musical instruments as per specifications in para 2 above.
- ii) Bidders are to submit certificate of registration of the entity from appropriate authority, valid trade license, IT clearance certificate during the last 3 years (2019-20, 2020-21, 2021-22), GST registration certificate & at least 30% credential for bulk supply of musical instrument in any of the last 3 financial years.
- iii) Bidders are to submit EMD of Rs. 2.00 lakh online through ICICI payment gateway following the provisions of wbtender.gov.in.
- iv) Bidders are to submit sample set of musical instruments following the specifications in para 2 above as per the below mentioned schedule:

vi) Technical bid will consist of documents as mentioned in para 5 (ii) above.

vii) Financial bid shall be quoted in the specified BOQ.

viii) Technical Bids shall be opened first and evaluated on the basis of criteria as mentioned in para 5 (ii) above. Financial bids shall be opened in respect of technically qualified bidders only as per the schedule. Financial bid shall be evaluated on the basis of rate quoted per set. The lowest rate quoted by a bidder shall be declared as L1 bidder and shall be awarded. In case of a tie bid the award may be distributed equally or as may be determined by the Corporation. In case, L1 bidder disagree or fail to supply L2 bidder shall be offered to supply in L1 rate and so on. However, decision of the Corporation shall be final and binding.

6. In case the L1 bidder accepts the award, EMD of the L1 bidder will be treated as performance security.

7. Payment shall be released by the Corporation on receipt of bill along with challan indicating receipt of musical Instruments by concerned district authority.

7. In case of failure to supply within stipulated time schedule or mismatch in specifications, the award shall be cancelled and performance security will be forfeited.
