ORDER

'West Bengal Scheduled Castes, Scheduled Tribes and Other Backward Classes Development & Finance Corporation' (WB SC, ST & OBC Development & Finance Corporation) has been constituted under a State Legislation (Act XXX of 2017). The Act has been notified in the official Gazette vide No. 1092-L dated 13<sup>th</sup> September 2017, of the Law Department and enforced with effect from 15<sup>th</sup> November 2017 in the State of West Bengal by Notification No. 3737-BCW-7P-16/17 dated 6<sup>th</sup> November 2017 of the Backward Classes Welfare Department, Government of West Bengal.

Now, the Governor is pleased to approve the proposal for opening a new 'Deposit Account' for the newly constituted 'WB SC, ST & OBC Development & Finance Corporation' with PAO-III, Salt Lake and declare Managing Director of the said Corporation as operator of this Deposit Account. All funds lying with the Deposit Account of the erstwhile WB SC & ST Development & Finance Corporation shall have to be transferred to the new Deposit Account.

Managing Director shall also function as Drawing & Disbursing Officer (DDO) of the new Corporation.
