**NOTICE INVITING TENDERS**

West Bengal Scheduled Castes & Scheduled Tribes Development & Finance Corporation (WBSBSTDFC) intends to procure about 60000 (Sixty thousand) bicycles for ST Girl Students of Class IX to XII of recognized schools located in all the 341 Blocks of the State. The Bicycles will have to be suitable for use in all terrain and weather conditions and spare parts/ accessories for its repair/ maintenance should be readily available. The Bicycles will have to be supplied in fully roadworthy condition, completely fitted with best quality accessories strictly in conformity with the technical specifications provided in **SECTION-II of the Tender document**.

Sealed Tenders are therefore invited from **reputed manufacturers** with **Annual Turnover of Rs. 100.00** crore in each of the last Five years, having widespread Distributorship/ Dealership/ Service Network covering entire geographical area of the State of West Bengal and having credentials of bulk supply to Government/ Public sector Undertaking/ Corporations/ Statutory Bodies under Government during the last five years @ at least 25000 bicycles per year.

Tenderers should quote a single rate, rounded off to the nearest Rupee for each piece of Ladies Bicycle. Rates should be inclusive of WBVAT, all other duties, taxes, charges, levies as well as the assembly and transportation charges of the bicycles to the Block Headquarters concerned. Each Tenderer will have to supply a sample Bicycle, completely fitted and compliant with the specifications provided in **SECTION-II. The Sample Bicycle should reach Head office of the Corporation located at CF-217/A/1 Sector-I, Salt Lake, Kolkata -700064 during 11.00 AM to 1.00 PM on the 15<sup>th</sup> January, 2013**. Two copies of the receipt would be given against deposit of each sample bicycle, one of which should be enclosed along with the Tender as a documentary evidence of submission of the sample.

Interested parties will have to submit Financial Bid on their Company Letter Head in the format as prescribed in the **Tender Document (SECTION-V)** addressed to the Managing Director, West Bengal Scheduled Castes & Scheduled Tribes Development & Finance Corporation in a separate sealed Cover super-scribing "**FINANCIAL BID**". Company Profile along with relevant records & credentials in the format as prescribed in the Tender Document **(SECTION-III) and Earnest Money of Rs. 45,000,00/- (Rupees Forty-five Lakh only)** in the form of an Account Payee Demand Draft drawn in favour of West Bengal Scheduled Castes & Scheduled Tribes Development and Finance Corporation and payable at Kolkata, will have to be submitted in another sealed cover super-scribing "**TECHNICAL BID**".
