2. The prospective bidders stated that they needed no further clarification with respect to the Bidding Documents.
3. Mr. Subir Ghosh, Unirox Bikes Pvt. Ltd. requested to amend clause 17 of e-NIT by increasing the quantity of bicycles reserved for local manufacturers from 1,00,000 to 2,00,000 & also to increase the delivery period of those bicycles. He was informed that presently there is no scope of major change of the Bidding Document as it has been approved by the FD. However, the matter may be taken up with the higher authorities before publication of EOI for local manufactures.
4. The Committee emphasized the strict compliance by the prospective bidders of the Bidding Schedule as contained in the Bidding Documents.
5. The Committee further decided that the minutes of the pre-bid meeting may be uploaded in the official portals of Saboojsathi & the Corporation.
