**NOTIFICATION**

No. 3248-BCW/6M(MC)-3/13 (Pt-III), dated the 31<sup>st</sup> December, 2021.- In exercise of the power conferred by sub-section (1) of section 26 of the Prohibition of Employment As Manual Scavengers And Their Rehabilitation Act, 2013 (No. 25 of 2013) (hereinafter referred to as the said Act) and in supersession of the earlier notifications on the subject, the Governor is pleased hereby, to constitute, with immediate effect, the State Monitoring Committee, with the following members, namely:-
